# About Stud Service



BADOGINC, LLC. provides stud services to owners of registered dams only. A non-refundable deposit of \$500 is required to lock in the stud dog at this rate, otherwise rates are subject to change. Stud fee must be paid in full before breeding is completed. Our stud credits can not be sold or transferred by our clients, without prior approval from BADOGINC, LLC. All parties legally involved with said dam must provide a signature, or risk denial of registration.

BADOGINC, LLC. agrees to have the stud dog in good physical condition & sign litter registration paperwork promptly, with swift return to owner of dam. We will provide a maximum of 2 repeat breedings if dam fails to produce a litter. A litter consists of 2 LIVE puppies. Owner of dam will cover costs of shipping only for repeat breeding(s).

Owner of dam will notify BADOGINC, LLC. (in writing) of failed conception no later than 70 days after time of breeding. However, if stud happens to become unavailable for use, due to unforeseen circumstances, BADOGINC, LLC. reserves the rights to substitute another stud(s) of equal value to owner of dam.

Progesterone testing is required for dam, by a licensed veterinarian before repeat breeding(s) takes place.





Owner of dam is responsible for keeping the female in good condition, and properly confined whereas no other stud dogs can breed with her. NO DUAL SIRES ALLOWED. Females bred to any stud dog other than the one provided by BADOGINC, LLC., during her breeding season, will void all repeat breeding privileges, and forfeit signature of litter registration by BADOGINC, LLC.

Owner of dam agrees that they will not knowingly sell any puppies from this pairing to any persons or entities connected to wholesale or resale of animals.

We guarantee quality semen at the time of breeding, but in no way do we guarantee conception. Once semen is evaluated and shipped to owner of dam, conception is 100% dependent on the female, the type of breeding completed, and the experience of the person(s) performing the breeding. BADOGINC, LLC. is not responsible for any happenings after semen is shipped.

To keep the value of BADOGINC, LLC. and our clients appreciated, no pup is to be sold for less than half the price of the current stud fee. If stud credit is not used within 2 years of purchase, BADOGINC, LLC. reserves the right to charge the owner of the dam the cost of freezing stud semen. If dam is sold while pregnant, a separate Stud Proposal must be agreed upon and signed by the new owner.

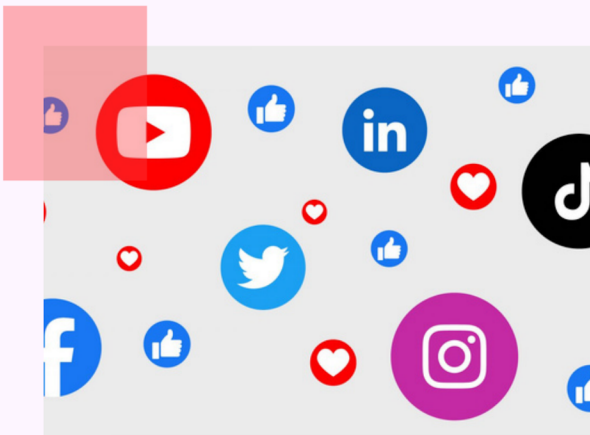

# Additional Conditions

BADOGINC, LLC. reserves the right to request all info pertaining to a repeating breeding. X-Ray is required as proof of non-conception. X-Ray is also required as proof of litter size. If owner of dam fails to provide an X-Ray performed by a licensed veterinarian, owner runs the risk of forfeiting a repeat breeding. Cesarian Sections are HIGHLY RECOMMENDED as the American Bully produces wide bodied, and large headed puppies. BADOGINC, LLC. not responsible for deceased puppies resulting from natural whelping.

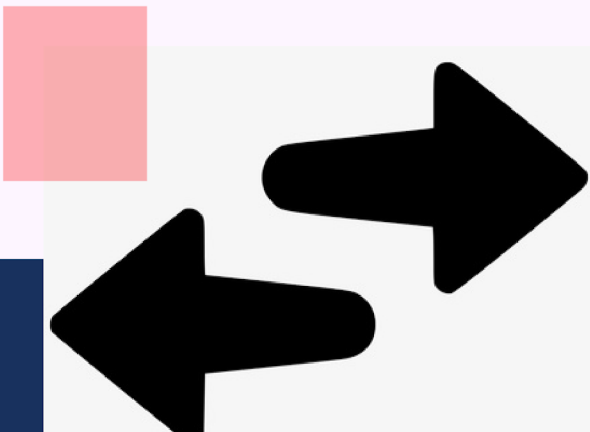

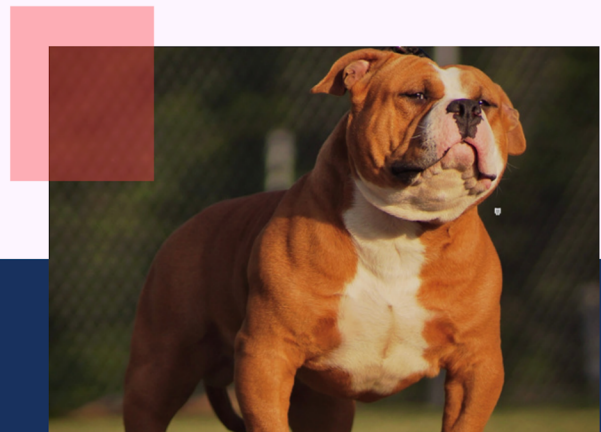
reserves the right to request DNA testing on any pup that is questionable in traits from owner of dam.
